History of FQHC LIP Categories

- LIP funds were provided for eligible providers to cover health care costs for which compensation was not available from other payors.
- LIP provided government support for providers that furnished uncompensated care to the Medicaid, underinsured, and uninsured populations.



History of FQHC LIP Categories (Cont.)

- LIP was also designed to establish new, or enhance existing, innovative programs to improve the quality of care for low income populations.
 - \$7.2 million Department of Health (DOH) funds
 - To provide funds for county health initiatives emphasizing the expansion of primary care services and rural health networks.
 - Primary Care Initiatives
 - To provide services most needed by local communities; expand local capacity to treat patients; reduce unnecessary emergency room visits and preventable hospitalizations.
 - \$11 million
 - To provide Medicaid low-income pool payments to FQHCs to support primary care services in medically underserved areas.

Additional Non-LIP Funding for FQHCs SFY 2015 - 2016

- FQHCs were not included in LIP for SFY 2015-16 and SFY 2016-17, but were eligible to receive funding from other sources.
- Grant Program for Community Primary Care Services
 - Available funding: \$28,550,939
 - Increase access to primary care services in order to expand primary care clinic services for the uninsured and underinsured. Intended to reduce unnecessary emergency room visits and preventable hospitalizations.
- Department of Health Grant for Community Health Centers
 - Available funding: \$18,276,256
 - Distribution of funds to eligible FQHCs in accordance with the provisions of Chapter 216, Florida Statutes.

Additional Non-LIP Funding for FQHCs SFY 2016 - 2017

- Department of Health Grant for Community Health Centers
 - Available funding: \$9,000,000
 - Distribution of funds to eligible FQHCs in accordance with the provisions of Chapter 216, Florida Statutes.

New LIP STCs

- Beginning in SFY 2017-18, the STCs for LIP changed significantly from previous demonstration years.
- The new LIP program provides government support for safety net providers for the costs of uncompensated charity care for low-income individuals who are uninsured.
- Uncompensated care (UC) includes charity care for the uninsured but does not include UC for insured individuals, "bad debt", or Medicaid and CHIP shortfall.
- The total allotment for LIP (\$1,508,385,773) was calculated solely on total hospital charity care costs.



Changes to Payment Methodology

- Providers may be categorized in up to three groups:
 - Hospitals
 - Medical School Physician Practices
 - FQHCs/Rural Health Clinics (RHCs)
- Each group can be divided up to five tiered subgroups based on ownership, UC Ratio, or ownership and UC Ratio.
- UC Ratio is the amount of a provider's uncompensated uninsured charity care costs, expressed as a percentage of its privately insured patient care costs.
- FQHCs/RHCs are limited to a \$50,000,000 allotment each year.



Changes to Payment Methodology (Cont.)

- All providers within a subgroup (tier) must be paid the same percentage of their charity care costs.
- A subgroup (tier) with a lower range of UC Ratio cannot be paid a greater share of their charity care costs than providers in tiers with higher UC Ratio.
- LIP payment calculation is not based on Intergovernmental Transfers (IGTs) contribution.
- IGTs are voluntary and there is no guaranteed return.



Participation Requirements

- FQHCs must meet participation requirements to be eligible to receive LIP funds.
- FQHCs must contract with at least 50% of Standard Plan MCOs in their region.
- Providers must be enrolled in Medicaid.
- A provider who meets the participation requirements must be paid their portion of LIP funds regardless of IGT contribution.
