

Statewide Medicaid Managed Care Public Input Opportunities

House Bill 7107 was passed in the 2011 Florida Legislative session and signed into law by Governor Rick Scott. This bill requires the Agency to seek federal authority to implement the Statewide Medicaid Managed Care Program, which includes both Long Term Care and Medical Assistance.

The application for federal authority must be submitted by August 1, 2011. Additionally, the Agency is required by law to allow 30 days for public input prior to August 1, 2011. The Agency has opened this opportunity to the public in the following ways:

Public meetings

The Agency scheduled public meetings in each of the 11 Medicaid regions throughout the state. By law, these meetings must be advertised in the Florida Administrative Weekly for at least seven days. The notice was published on June 3, 2011 for all 11 meetings to be held June 10 – 17, 2011. Attendees will be given the opportunity to provide input at those meetings, which will be collected for consideration in the federal application.
