April Monthly Actions: Agency Took Licensure Action against 16 Providers, 14 Additional Providers Terminated from the Medicaid Program

Tallahassee, Fla.—The Agency for Health Care Administration (Agency) issued final orders to 15 providers for failure to meet licensure requirements during the month of April. The Agency issued six final orders to deny a license renewal application, eight to revoke an existing license, and one change of ownership denial. Some of these providers were enrolled in the Medicaid program; however, the Agency has terminated or is in the process of terminating their participation in the program.

In addition to the final order actions, the Agency issued an emergency suspension and placed a moratorium on admissions for Senior Lifestyles, LLC d/b/a Kipling Manor Retirement Center, an assisted living facility in Escambia County, because survey inspections found issues that caused a serious threat to residents.

Fourteen additional providers were issued a final order terminating them from participation in the Medicaid program in April. These terminations resulted from sanctions imposed for failing to reimburse Agency, termination from Medicare/Medicaid program, and for failure to furnish records within the timeframes established by the Agency. These providers also have been reported to the federal government for placement on the federal exclusion list, which prohibits them from participating in Medicaid and Medicare nationwide.
