October Monthly Actions: Agency Took Licensure Action against 17 Providers, Two Additional Providers Suspended from the Medicaid Program

Tallahassee, Fla.— The Agency for Health Care Administration (Agency) issued final orders to 17 providers for failure to meet licensure requirements during the month of October. The Agency issued seven final orders to deny a license renewal application, six to revoke an existing license, and four that resulted in the providers surrendering their license. Some of these providers were enrolled in the Medicaid program; however, the Agency has terminated or is in the process of terminating their participation in the program.

There were also two providers suspended from participation in the Medicaid program prohibiting the providers being paid for claims to the Medicaid program for furnishing, supervising a person who is furnishing, or causing a person to furnish goods or services.
