March Monthly Actions: Agency Took Licensure Action against Ten Providers

Tallahassee, Fla. – The Agency for Health Care Administration (Agency) issued final orders to ten providers for failure to meet licensure requirements during the month of March.

There were three final orders to revoke an existing license, five final orders to deny a license renewal application, and two that resulted in the provider surrendering their license. Some of these providers were enrolled in the Medicaid program and the Agency has terminated or is in the process of terminating their participation in the program.
