October Monthly Actions: Agency Took Licensure Action against Seven Providers, Two Additional Providers Terminated from the Medicaid Program

Tallahassee, **Fla.** – The Agency for Health Care Administration (Agency) issued final orders to seven providers for failure to meet licensure requirements in October.

There were five final orders to revoke an existing license and two final orders to deny a license renewal. Some of these providers were enrolled in the Medicaid program and the Agency has terminated or is in the process of terminating their participation in the program.

In addition, two providers were issued a final order terminating them from participation in the Medicaid program and have been reported to the federal government for placement on the federal exclusion list, which prohibits them from participating in Medicaid and Medicare nationwide.

The Agency's Medicaid terminations and suspensions typically result from sanctions imposed for failing to reimburse the Agency within the timeframes set; being charged by information or indictment or pleading guilty to a health care related crime; being suspended, terminated, or excluded from the Medicare or Medicaid program in another state; or for having a license denied, revoked, suspended or terminated by the licensing agency.
