## **Agency Announces Primary Care Services Grant Recipients**

- AHCA awards more than \$28 million to local health facilities -

**Tallahassee, Fla.** – Today, the Agency for Health Care Administration (AHCA) awarded 60 county health departments, community health centers, and federally qualified health centers primary care services grants, totaling more than \$28 million. Recipients of the grants are intended to reduce health spending and improve the health status of uninsured or underinsured persons around the state.

AHCA Secretary Elizabeth Dudek said, "We are thrilled to be able to present these deserving applicants with the primary care services grant that will improve quality and access to care around the state. Florida's county health departments and community health centers are important cornerstones of public health, and we are proud to provide funding for programs that will help serve the health care needs of their communities."

The primary care services grant, which is intended to improve access to primary care services and reduce or prevent unnecessary emergency room visits or hospitalizations, made more than \$28 million available for fiscal year 2015-2016. These funds will allow award recipients to implement a variety of programs including expanded clinic hours, added capacity to expand primary care services, engagement in disease management and health education, expanded dental/oral health services, and the addition of behavioral health services to existing service options.
