
Medicaid Program Updates

Medicaid Enrollment

- Total enrollment as of July 15, 2022: 5.36 million recipients.
- A 3-month increase in enrollment is equal to 129,568 recipients or an increase of over 2.5%.
- The largest portion for the enrollment increase has been children and families (TANF), and the FFS population has decreased while the managed care population has increased.

Complaints & Fair Hearings


- During the PHE, the numbers of complaints and Medicaid Fair Hearing Requests submitted to the Agency have remained steady, despite the rising numbers of Medicaid eligibles. Reasons for this include:
 - Agency has complied with federal mandate to maintain Medicaid eligibility for most recipients through the end of the PHE. This has resulted in fewer complaints from recipients and providers pertaining to loss of coverage.
 - Agency has waived and postponed several program requirements, and offered multiple provider flexibilities during the PHE, to ensure recipients receive necessary care.

1115 Waiver Amendment Updates

The 1115 Waiver Amendment was approved by CMS on 5/25/22. This amendment approved:

- Extension coverage to 12 months for post partum individuals in Medicaid and CHIP.
 - SB 2526: Health (Conforming Bill) was approved by the Governor on 6/2/22 and extends the postpartum period to 12-months for CHIP recipients.
- Low Income Pool (LIP)
 - Allows for certain non-profit licensed behavioral health providers to be eligible to receive funding from the LIP program and is expected to increase access to behavioral health care in Florida.
 - Allows non-profit licensed behavioral health providers, who participate in the coordinated system of care in counties that have implemented indigent care programs, as qualifying community behavioral health providers eligible to receive LIP funding.





HCBS Funding Opportunity

- The American Rescue Plan Act (ARPA) went into effect April 1, 2021.
- Section 9817 of this Act authorized an increased Federal Medical Assistance Percentage (FMAP) to support Home and Community-Based Services (HCBS).
- There are three one-time funding opportunities currently available:
 - Provider Stipend Payments
 - Provider Retention Payments
 - Delayed Egress

Minimum Wage Proviso

- \$1 Billion allocated to cover minimum wage increase to \$15 per hour for direct care workers of Medicaid providers effective July 1, 2022

SMMC Re-Procurement

- The Agency must re-procure health plans every 6 years through an Invitation to Negotiate (ITN).
- The Agency is currently in its second contract term (2018-2024) and is in the process of procuring health plans for the third contract term (2025-2031).
- The Agency issued a Request for Information (RFI) on 5/6/22 to solicit information regarding the re-procurement. We have received 58 RFI responses from stakeholders during the current re-procurement.

Subpopulation Committee Update

- In addition to the MCAC, the state has established smaller advisory committees that meet on a regular basis (at least quarterly) to focus on the following subpopulations:
 - managed long-term services and supports;
 - beneficiaries with HIV/AIDS;
 - children, including safeguards and performance measures related to foster children;
 - the provision of dental care to all children; and
 - behavioral health/substance use disorder services.
- Kickoff meetings were held in June, 2022.


