Dear Ms. Webb,

On behalf of the leadership and staff of FMDA, thank you for supporting our statewide project titled, Leveraging Clinical Staff Engagement – A Certificate of Excellence in PALTC.

It has been two years since the original contract was executed, and 21 months since we launched this exciting project – at the height of the COVID-19 pandemic. During that time, we gained valuable experience and insight into the ever-changing needs of the long-term care professional community and the enhanced value of the Certificate of Excellence program.

Attached for your review is a detailed, 34-page report that highlights the high-quality education we provided scholarship recipients. Scholarships were awarded to eligible medical directors, physicians, advanced practice nurses, physician assistants, consultant pharmacists, nurse administrators, registered nurses, nursing home administrators, and qualified full-time interprofessional trainees in medicine, nursing, pharmacy, and allied health from undergraduate, graduate, postgraduate, and doctoral educational programs throughout the State of Florida with an active Florida license.

The individual session and speaker evaluation results may be found on pages 1-21. The program evaluation results are on pages 22-29, and the formal needs assessment questions follow on pages 29-34.

The results highlight the evaluations for all 25 presentations and each of the 39 faculty members. As you can see, the report shows that the average rating combined was more than **4.85** out of **5.0**. The same document includes unredacted and unmodified comments and feedback. In addition, we surveyed each participant about the program, and the results are overwhelmingly positive, and we couldn't be more proud. Here is one example:

While we had great interest and engagement from many eligible applicants, we faced challenges in getting participants to complete the program. The COVID-19 pandemic had a significant impact on healthcare providers, who faced increased workloads, burnout, vaccine hesitancy, and attrition. As a result, some participants found it



difficult to find the time and energy to complete the program. In addition, many dedicated, experienced, long-term SNF employees left their work for jobs in other industries. Combined with an increased pressure on existing staff, it has created a severe staffing shortage. This has been a major, ongoing barrier to participation in this training. As a result, we hosted fewer participants than were originally estimated.

Despite these challenges, FMDA worked hard to support its participants by providing additional resources and flexible completion options. We also recognized the importance of providing ongoing support and encouragement to our participants throughout the program to ensure their success.

We will continue to encourage enrolled participants to complete the program and to that end, we will be maintaining the online Socio/Webex platform and keeping it active until Aug. 31, 2023.

During the course of the program, we learned that we could have made it easier for participants to keep track of completed sessions. We received feedback from some participants who found it challenging to keep track of which sessions they had completed, and which ones still needed to be finished.

In hindsight, while we may have overestimated the number of potential participants, we are very pleased with the results. One thing we might have done differently was to possibly lower the total number of required hours to earn the certificate – 20 was the minimum out of a total of 29. This time commitment may have been viewed as a barrier to some potential participants.

The selection of Socio as our mobile app./desktop platform was a great choice. It worked extremely well for us and the participants, and it functioned as intended and as we designed it. The fact that Webex purchased Socio last year only reinforces our choice.
