
## **BLACKOUT PERIOD**

Therefore, we have officially entered into the statutory blackout period as described in s. 287.057(25), F.S., and we must not have any discussions relating to the scope, evaluation, or negotiation of those procurements.

# Legislative Updates

#### **Certified Community Behavioral Health Clinics (CCBHC)**

- AHCA to develop a plan and seek federal approval to implement CCBHC's as a Medicaid covered service

#### **Comprehensive Intellectual and Developmental Disabilities Managed Care Pilot**

- AHCA to implement a Pilot Program for up to 600 individuals currently on the HCBS waitlist at APD

#### Florida Birth-Related Neurological Injury Compensation (NICA) Plan Report

- AHCA and NICA to complete a report regarding Medicaid TPL functions

#### **Program for All-Inclusive Care for the Elderly (PACE)**

- PACE Organizations to enter into two-party contracts with AHCA
  - AHCA to submit a monthly PACE report to the Legislature



#### **Rapid Whole Genome Sequencing**

- AHCA to add rapid whole genome sequencing as a covered fee-for-service benefit for certain enrollees.

#### **HB 967: Medicaid Coverage of Continuous Glucose Monitors**

- AHCA to move continuous glucose monitors (CGM) and related supplies required for use with those monitors from DME to the pharmacy point-of-sale.

#### **HB 121: Florida KidCare Program Eligibility**

- Increases the MediKids, Florida Healthy Kids and Children's Medical Service program eligibility upper income limit and creates a tiered system of premiums for certain enrollees under the Florida KidCare program.

#### **HB 391: Home Health Aides for Medically Fragile Children**

- Allows parents employed by Home Health Agencies to serve as a Home Health Aide for their child.
- Requires AHCA to develop training for the Home Health Aide.



#### **SB 2510: Health**

- AHCA to remove the Medicare certification or its accreditation equivalent requirements for home health agencies that do not provide Medicaid skilled home health services and provide only nursing care services or private duty nursing services, or both.

#### SB 1352: Sickle Cell Disease Medications, Treatment, and Screening

 AHCA and other entities to review sickle cell disease medications, treatments, and services for Medicaid recipients and develop a written report.

## Legislative Budget Updates

#### Medicaid Budget: \$35.5 billion

- Medicaid Provider Rate Increases \$73.5 million
  - Durable Medical Equipment (DME)
  - Intermediate Care Facilities for Individuals with Intellectual Disabilities
     (ICF/IID) Maternal Fetal Medicine
  - Community Behavioral Health
  - 。 Organ Transplant
  - Pediatric Behavioral Health Services
  - Prescribed Pediatric Extended Care (PPEC)



## Legislative Budget Updates

- KidCare Workload \$47.8 million
- Pediatric Physicians \$76.1 million
- Children's Hospitals \$130.7 million
- Graduate Medical Education \$139.3 million
- Nursing Home Reimbursement Rates \$125 million
- Personal Needs Allowance Increase \$17.7 million
- Rapid Whole Genome Sequencing Coverage \$3.3 million
- Program of All-Inclusive Care for the Elderly (PACE) \$60.3 million
- Florida Medicaid Management Information System (FMMIS) \$187.6 million

- Invitation to Negotiate (ITN) issued April 11, 2023
- Deadline for Receipt of Responses is October 25, 2023 at 12:00 p.m.
- Anticipated Date for Negotiations is December 4, 2023, through January 26, 2024
- Anticipated Posting of Notice of Intent to Award is February 23, 2024

• Invitation to Negotiate (ITN) anticipated posting in Fall 2023





# FX Strategic Roadmap – Phase 3






