Talking Points:

Registered Dental Hygienists (RDH)

- The Agency has begun the process of enrolling RDHs.
- Erica Thomas attended the annual conference for Dental Hygienists a couple of weeks ago and walked them through the needed information for enrollment.
- We are currently engaged in a pilot program with an FQHC and CHD to walk through the process and look for any chinks in the system, predict times frames more effectively, and develop a better grasp of the magnitude of numbers we plan to see enrolling.
- For a quick overview:
 - RDHs may enroll on the enrollment wizard through the web portal, as the sole proprietor enrolling as a member of a group.
 - They then select provider type 37, which has been assigned to RDHs, Primary Specialty 937, and taxonomy 203BA0003X
 - They will then be instructed to make sure they have a list of required information prior to moving forward with the process.
 - At this point it is the simple matter of filling out all the papers and uploading the necessary documents as prompted on screen.
